Show & Show Site Rules

- All Bulldogs will be judged on a ramp
- No Dogs are to be left in building overnight. Dogs must only be exercised in the designated outdoor exercise area
- Exhibitors should follow their Veterinarians' recommendations to assure their dogs are free from internal and external parasites, communicable diseases and have appropriate vaccines
- Grooming and crate set-up areas will be designated. Only small battery-operated crate fans are allowed. There will be no reserved grooming at the show, but plenty of space will be available
- Errors: Errors on the entry forms are the responsibility of the owner or whomever made the error and no entry fee will be refunded in the event of such error or cancellation of entry after the published closing date.
- Bred-By-Exhibitor Class: All dogs entered in the Bred-By-Class must be individually registered with the AKC, and the person handling the dog must be a breeder of record of the dog and an owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record.
- All dogs must be individually registered by the day of the event to be eligible to exhibit at an AKC event. No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. Only dogs that are individually registered with a foreign registry organization and whose registration with the AKC has been delayed will be eligible for an extension.
- Parking and at the show site. Crates should be unloaded by parking
- Admission to show is free. Exhibitors are encouraged to bring own chairs
- Show room will have a concrete floor
- Smoking is prohibited inside the building
- Alcoholic beverages may not be consumed, served or sold on premises. Local authorities may check for violations of this policy, and if found, the Show will be ended!
- The Austin Bulldog Club assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers or any of their dogs or property. The club further assumes no responsibility for injury to children
- Parents and Guardians must keep children under control at all times on the show grounds. The welfare of an exhibitor's child is the sole responsibility of the exhibitor

1. Entries must be submitted on an American Kennel Club (AKC) Official Entry Form or exact copy (both front & back) and must be signed. Owners are responsible for errors on entry blanks. The Club and/or its Show Secretary assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or owner's Agent entering a dog or a class for which the dog is not eligible to compete. Conditional entries are not accepted.

2. **Make checks payable to Austin Bulldog Club.** No cash will be accepted. **ENTRIES CLOSE 6pm CST, WEDNESDAY, December 28, 2022 at the Show Secretary's address**

3. **Online entries will only be accepted by sending a completed Entry Form to the Show Secretary by email, and paying the appropriate fees using PayPal (Friends and Family) to Helcim In Notes, reference AKC registration number. Please add \$2 fee for each online entry.**

4. Exhibitors are advised to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available from the Show Secretary or may be obtained from the AKC.

5. A recording fee of 50 cents and a Event Service Fee of \$3 will be required for each dog entered at any licensed or member club show. This recording fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. (AKC Rule, Chapter 14, Sec. 2).

6. Judging programs will be emailed to the email address given on the entry blank.

7. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Show Committee. If, because of riots, civil disturbance, natural disaster, or other acts beyond the control of the Show Committee, it is impossible to open or complete the show, no refund of entry will be made.

8. There will be a \$35 fee for all checks returned for insufficient funds. All check must be drawn in US Funds.

9. A dog which, according to its owners' records, has completed the requirements for a Championship after the closing of entries for the show, but whose Championship is unconfirmed, may be transferred from one of the regular classes to Best of Breed, provided this transfer is made by the Show Secretary at least one half hour prior to the start of any regular conformation Judging at the show.

10. Trophies and cash prizes will be awarded in the judging rings. In the event of a discrepancy from the published prize list, the Show Secretary should be advised at once. Trophies not claimed on the day of show are forfeited.

11. Fees must be submitted with checks drawn on U.S. accounts, in U.S. funds.

12. Entry fee shall not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of Show Committee or because it has been entered incorrectly.

13. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fee will be made.

Winner of these classes, if otherwise undefeated, complete in Best of Breed Competition. Veteran Dog/Bitch (7yrs and older)- open to champions and non-champions. A dog may be entered in the Veteran Class without being entered in any other class. Dogs/Bitches will be judges separately. Chapter 11, Section 8 AKC Rules, neutered males may be entered as a Veteran Dog/ Spayed females may be entered as Veteran Bitch.

Novice Dog/Bitch, Brood Bitch classes, Rescue Parade, Parade of Champions are not offered.

SWEEPSTAKES

Sweepstakes is open to bulldogs which on the day of the show are at least 6 months of age and under 18 months of age. Entrants must also be entered in a Regular Class of the show. A Champion of Record may not be entered or shown. Professional Handlers may show their OWN DOGS ONLY. To enter, mark "ABC Sweepstakes: with the Class and Age Division on the Entry Form.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
